- In the apartment free **Wi-Fi** is available. By using the code, the guest accepts the following usage agreement (*). The code is:
- In order to offer the guests after you also a decent apartment, I ask you to tell me any **defects** and **damage** immediately, so I can plan the repairs.
- Please **close all windows** when leaving the apartment. Please ventilate the apartment daily.
- Please put the **garden furniture** under roof during the night and in case of rain.
- Please use a separate sleeping place of your pet. The beds and seating are **only for bipeds**. In addition, please remove any pollutions from the garden.
- Please do not take **skis**, **sports equipment** and **wet sportswear** into your living room.

- If necessary, please take care of **snow clearing** the driveway, parking lots and Access with the equipment provided including de-icing salt.
- Please behave quietly, especially between 22:00 and 8:00.

The use is free of charge and limited to the duration of the presence in the Chalet Rauscher. No warranty can be given by Chalet Rauscher for the actual availability of the Internet access. The code may not be handed out to anybody else.

By issuing the code, the Chalet Rauscher assumes no obligations. The use is made according to the technical possibilities. In particular, the user has no right to use the Internet Wi-Fi in any particular way or duration.

This excludes any liability, in particular for warranty and damages. In particular, no liability is assumed for the content of accessed websites or downloaded files. Furthermore, no liability is accepted for any virus attack by using the Internet Wi-Fi.

The user expressly acknowledges that the Internet WLAN only allows access to the Internet, but does not contain any antivirus or firewall.

The use of illegal websites or the distribution of unlawful or legally protected content is prohibited.

In particular, the user is expressly prohibited from using the Internet WLAN for downloading or for any other distribution of copyrighted content.

Any improper use of the Internet Wi-Fi, in particular a use that may entail adverse legal consequences for third parties or the landlord is prohibited.

Should the landlord be exposed by the use of the Internet Wi-Fi by the user for any reason third party claims, so the user is obliged to indemnify and hold the landlord in this regard.
